

**Objective & Strategy**

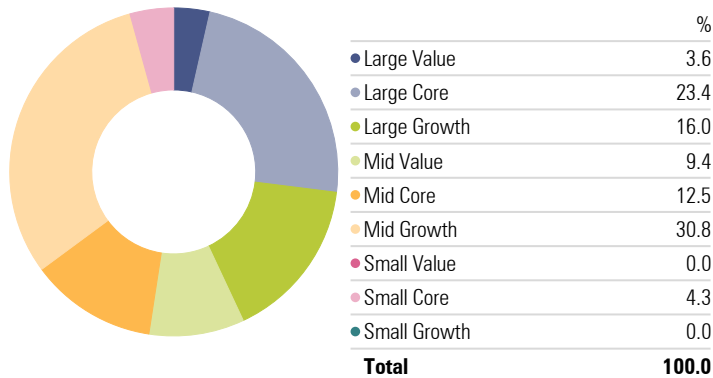
This strategy seeks long-term capital appreciation. The manager aims to achieve this goal by investing primarily in mid and large-capitalization companies with strong earnings growth potential.

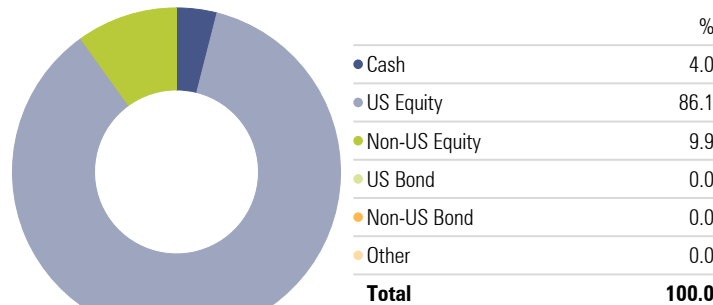
**Market Capitalization of Equities**
