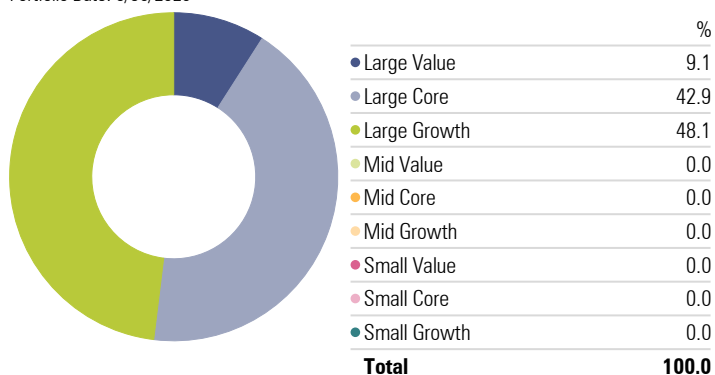

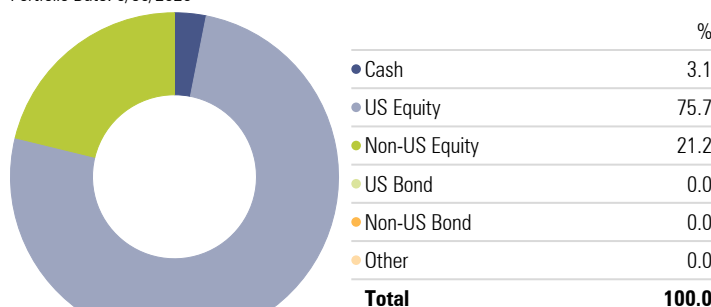
### Market Capitalization of Equities
