

Objective & Strategy

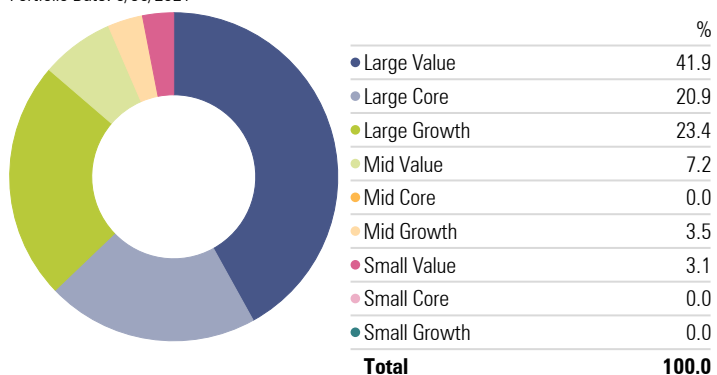

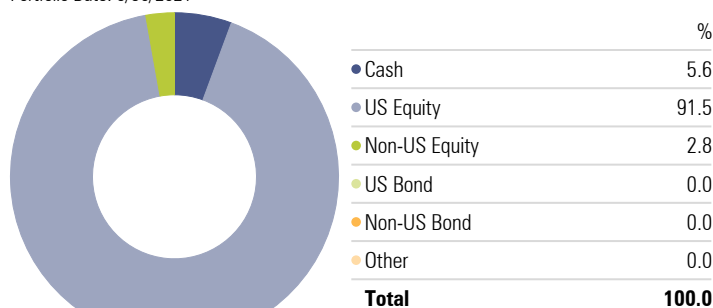
Market Capitalization of Equities
