

### Objective & Strategy

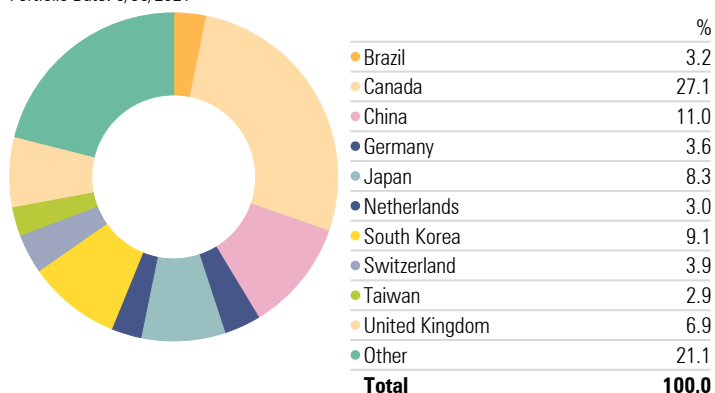

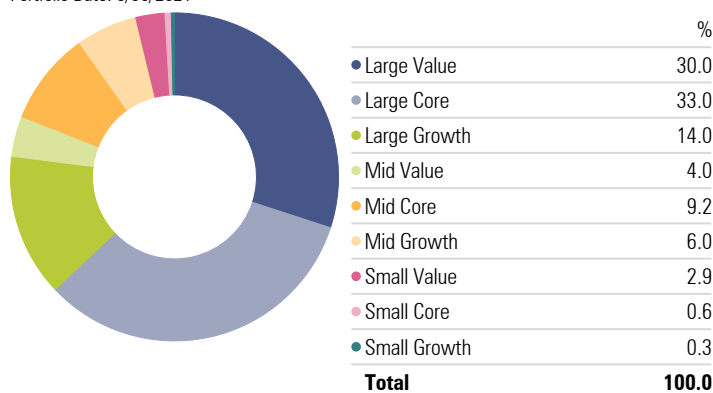
### Country Exposure
