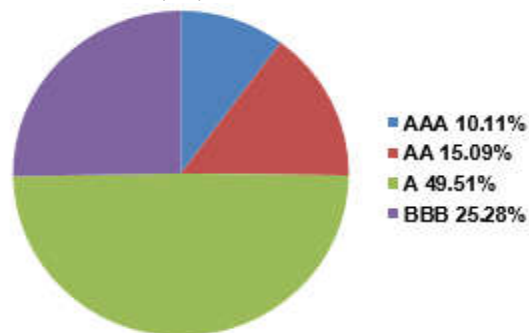


### Objective & Strategy

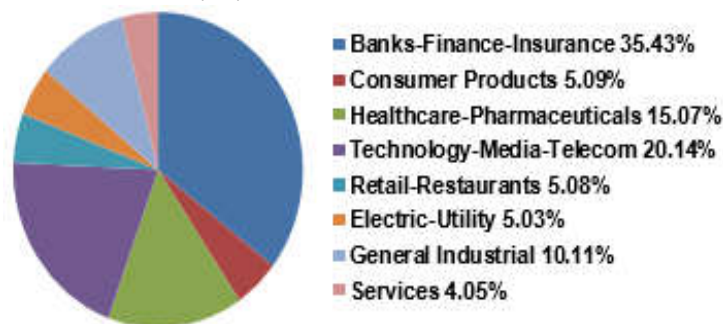
### Rating Distribution
