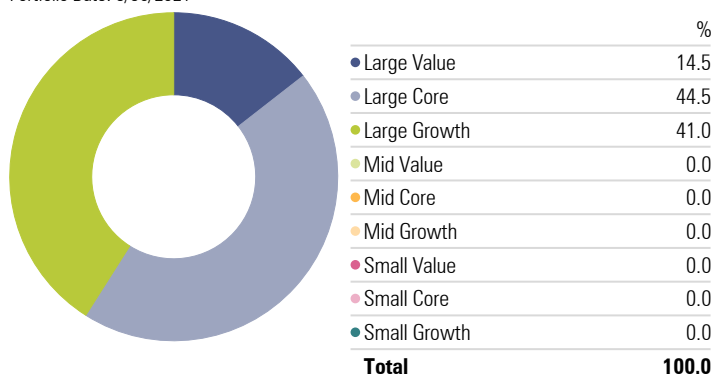

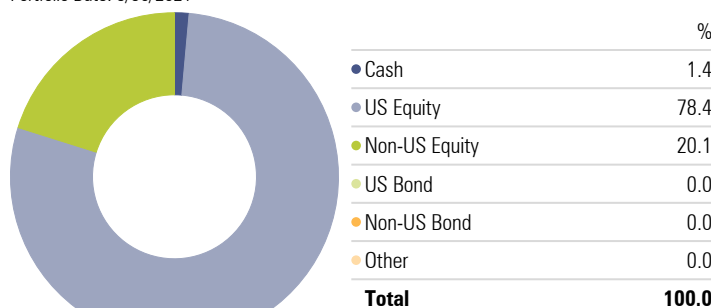
Market Capitalization of Equities
