Objective & Strategy

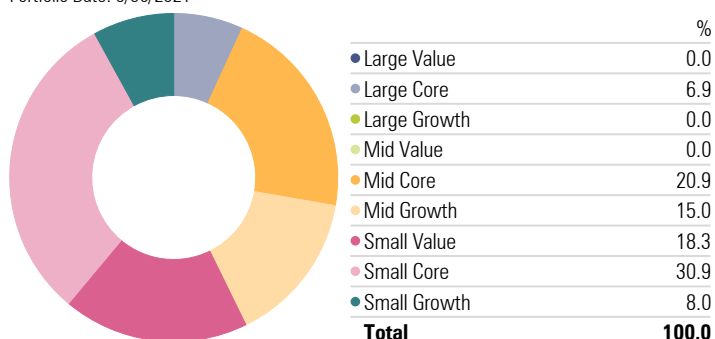

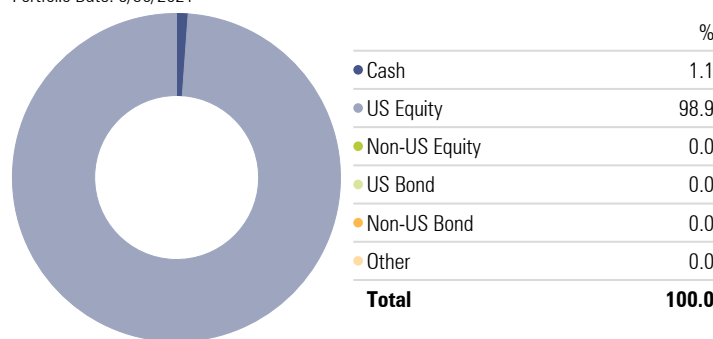
Market Capitalization of Equities

The Russell 2000 Value Index measures the performance of those Russell 2000 companies with lower price-to-book ratios and lower forecasted growth values.
